**Fire Chief Report**  
July 8, 2019

1. The District ran a total of 31 calls for the month of June 2019

2. Projects currently working on;
  - a. Brush-41 – **This is now in-service**
  - b. ISO rating – **Continue to work on this project**
  - c. District Policy, Procedure and SOG Manual – **This is an ongoing project**
  - d. Video Surveillance – **About 50% completed**
3. Grants
  - a. AFG – SCBA’s – **Been submitted**
  - b. Homeland Security – **Wasn’t awarded – 4 spots from the funding, working with Murray Paolo and preparing for next years application.**
  - c. Safer Act – **Been submitted – 4-year Recruit and Retention Person**
  - d. Fire House Sub’s – Vests – **Was not awarded**
  - e. VFA Grant – Pagers & Radio’s
4. If the Board is in favor, we would recommend that we piggy-back on the Portland Fire contract for new Scott Air Packs. This would be a cost savings to the District of \$20,000 to \$30,000.
5. Water Tender 4 is in service. We are using portable radios currently. We should have the parts and an old UHF radio that we hope will work, until November when we have funds to purchase the new Tri-band radio (cost is about \$6500).
6. Engine 4 we are watching as it has developed a leak in the water tank. If it gets any worse, we will need to remove it from service as we don’t recommend spending any funds on repairs as it is scheduled to be replaced in the next year.
7. The Volunteers will be providing EMS services at the Yamhill County Fair on the evening of July 30 and August 2. The volunteers will be attending a joint EMS Training on Wednesday evening at Mc Minnville Fire Station.
8. Working on the Specs for the New Engine would recommending getting it out with bids due back by the August 12, 2019 for Board action to award a contract.
