Jim Phillips introduced the budget committee members. He opened nominations for Chair of the budget committee meeting. Jim Phillips was nominated to serve as Chair for the meeting.

Motion:

Clint Giberson moved to appoint Janes Phillips as Chairman of the Budget Committee, seconded by Paul Van De Grift. Motion passed. (10) Ayes (0) Nays

- Chair Phillips turn the meeting over to the District Budget Officer Chief Jensen who presented the proposed budget to the committee. Chief Jensen began with the Budget Message
 - Accomplishments
 - Grants
 - The Challenges Ahead
 - Growth and Call Volume

There were no questions from the Committee members.

Chief Jensen continued his presentation.

- Resources
 - General Fund
- Expenditures

General Fund – Personal Services – Jay Disbrow purposed a 3% salary increase for the Chief and Assistant Chief. Discussion – Chief Jensen explained that the amount coming from the SAFER ACT Grant is max at \$50,000 for the Assistant Chief, any pay increase to that position would need to come out of the District General Fund.

Motion:

Jay Disbrow Moved that the Fire Chief and Assistant Fire Chief be given a 3% increase in Salary for the 2020/2021 budget year and approve the following changed to the 2020/20221 proposed budget. Change Personal Services Line 1 Fire Chief from \$73,855.00 to \$76,070.00, change Line 2 Assistant Fire Chief from \$0.00 to \$1,500.00, and change line 9 Conflagration from \$40,000 to \$36,285.00Seconded by Clint Giberson. Motion pass (10) Ayes (0) Nays

General Fund – Material & Services – Chief Jensen presented the proposed budget and answer questions regarding the Professional Services why the big change from last year to this year. Chief Jensen explained that due to the Gas Station on going issues we spent a lot more in Legal fees, that issues has been closed so we will see that number drop. It was also asked what line item new PPE came out of. Chief Jensen explained that replacing old PPE would come out of Maintenance and Repair, new PPE for new members would come out of Line 22 Small Equipment and for new people under the SAFER ACT GRANT it would

come out of Line 25. Ended discussion with no changes at this time. Chief Jensen also explained that the new Budget laws have changed so that were we used to have these items that are listed in Line 22, used to be on line 1 of the General Fund – Capital Outlay – Equipment. For items to be in Capital Outlay they most be over \$5,000 per item and have a life span of more than a year.

- General Fund Capital Outlay / Contingency No changes
- Reserve Funds Resources and Requirements
 - Equipment Reserve Fund. Chief Jensen advised that the Board had closed this fund due to the bank service charge each month and had moved that fund into the General Fund.
 - The Volunteer Firefighter Reserve Fund (VFRF). The Volunteer organization did not establish a non-profit status and, therefore, could not hold or distribute public funds, or those transferred from the District. The VFRF allows the District to act as a fiduciary for the Volunteer organization. Discussion was asked about raising this amount from \$3,000 to \$4,300.

Motion:

Paul Van De Grift made a motion to add 3% increase to the Volunteer Transfer. Paul Van De Grift resend his motion.

Paul Van De Grift made a motion to increase the Volunteer Transfer from \$3,000 in Line 17 of the Capital Outlay to \$4,300. Seconded by Jon Peasley. Motion passed. (10) Ayes (0) Nays

Clint Giberson made a motion to decrease the Material Services Line 3 Maintenance and Repair from \$35,000 to \$33,700 and reducing the total of the Materials and Services from \$323,550.00 to \$322,250.00. Seconded by John Gregor. Motion passed. (10) Ayes (0) Nays

Clint Giberson made a motion to increase the Volunteer reserve fund line 5 from \$3,000 to \$4,300.00. Seconded by Paul Van De Grift. Motion passed. (10) Ayes (0) Nays

Chair Phillips asked the members for questions or comments on the proposed Budget. Hearing none, he entertained a Motion to accept as presented the proposed Yamhill Fire Protection District Budget for the 2020/2021 budget year.

Motion: Clint Giberson moved to approve the Yamhill Fire Protection District

Budget of 2020-2021, as amended by the Budget Committee, and levy the

permanent rate of .9081 per thousand dollars of assessed value for

operation purposes and the Local Option Capital Levy of .55 per thousand dollars of assessed value for Capital projects. Approved are the 2020-2021 General Fund budgets in the amount of \$2,342,359.00, and the

Volunteer Firefighter Fund in the amount of \$18,725.00. seconded by Paul

Van De Grift. Motion passed (10) ayes, Zero (0) nays.

Before adjourning the Budget Committee Meeting, Chairman Jim Phillips thanked the Budget Committee for there time and work on the 2020-2021 budget.
